The Minutes of the 56th Annual General Meeting – March 2nd 2022 (held virtually via Zoom)

The Minutes for the 56th Annual General Meeting were reviewed.

Motion: It was moved by Mark Munro, seconded by Tim Shea that the minutes of the 56th Annual General Meeting be approved as read. CARRIED.

Business Arising from the Minutes: None

2022 Financial Reports: Presented by Steven Peters

The 2022 Financial Reports and the 2022 Budget were presented. Steven referred to the 2022 Income Statement and Balance Sheet. We are approaching about \$100,00 that we have spent on the Association in education programs and we are seeing the benefits of the rest of Canada embracing those programs.

Balance Sheet

- Capital Assets include \$51,144 for the CDP Course.
- Accrued Revenue includes an overpayment for the Intro to Concrete course development which will be refunded.
- Liabilities down significantly after paying off CEBA loan in November 2022.
- Prepaid expense includes \$5,000 down payment for 2024 AGM at Delta Fredericton.
- All issues pertaining to the 2023 AGM and Delta Fredericton have been resolved, without fees or penalties. The contract for our 2024 AGM fits the needs of the Association and we look forward to hosting our first in-person AGM event since Covid, in New Brunswick.

Income Statement

- Membership fees for Producers are up slightly.
- Events: Summer Meeting and Golf Tournament are a positive sign post-covid.
- CDP is gaining incredible traction and revenue has doubled over the past year.
- Event expenses have increased this year as we are beginning to host our regular pre-Covid events, including the Summer Family Meeting and Decementfest.
- CDP Seminar expenses are the royalty fees we pay for other Provinces taking the CDP course. It's a positive sign to see the
 course having traction throughout the Country.
- Audit and legal fees include the 2022 Bylaw Review, Lawyer consultation for 2023 AGM but does not yet include the 2022 Audit.
- Other Office Expenses are high but include all costs associated with the unanticipated office move (movers, mail forward, 1st month uHaul storage and Workspace membership).
- RMN postage expenses for 2 publications.
- Marketing/Advertising expense was increased due to Covid funding focusing on industry and employee recruitment.

Presentation of the 2023 Budget

- Presented a budget that would reflect the coming year with lifted Covid restrictions in mind. Planning to host the Summer Meeting
 at the Rodd Resort, Brudenell, PEI, Golf Tournament in September at the Moncton Golf Club and hopefully Decementfest in Monc
 ton. NB.
- Travel and Conference attendance expected to pick up in 2023. Planning to stick with virtual meetings where appropriate and cost-efficient.
- Expecting a slight reduction in Rent moving to home offices.
- Expecting an increase in education revenue/expenses bringing back courses like Pump, 2-Day Basics the Introduction to Concrete and the successful CDP program.

MOTION: Kent Nickerson motioned, and Bruce Casey seconded to approve the 2022 Financial Statements as presented. Carried. MOTION: Robert McGinn motioned, and Kent Nickerson seconded to approve the 2023 Proposed Budget as presented. Carried.

2022 Events

- 2022 Summer Family Board Meeting: Our popular summer board meeting was brought back in 2022 at the Algonquin Resort in St. Andrew's, New Brunswick. Our 2023 Summer Family Board Meeting will take place August 25-27 at the Rodd Resort in Brudenell, Prince Edward Island. Registration and event details are being finalized and early-booking is highly recommended.
- 2022 Golf Tournament: We hosted our 2022 at the Moncton Golf Club in Riverview, New Brunswick with a great turnout. Our 2022 Tournament winning team was Gemtec! We are hosting our 2023 Tournament again, at the Moncton Golf Club on September 21, 2023.
- Special Members Meeting Bylaw Amendments: In April 2022, Concrete Atlantic held a Special Members Meeting and made amendments to the existing Association Bylaws. Quorum requirements were revised and virtual meetings were included as a recognized way for the Association to hold meetings.
- 2022 Decementfest: We hosted our first Decementfest since the pandemic started and it was so nice to see everyone who was
 able to attend. Numbers were a bit lower than previous years. In 2023 we plan to host Decementfest in Moncton New Brunswick.
- Other Industry Events: ConcreteWorks2022 (Colorado), NS Road Builders President's Dinner-January 2023 (Halifax), Canadian Concrete Expo May 2022 & February 2023 (Toronto), NRMCA Convention 2023 March 2023 (Las Vegas).
- Environmental Product Declarations (EPD's): The Canadian federal government and Cement Association of Canada recently issues a joint plan to reduce the carbon footprint of concrete products through low carbon concrete procurement. EPD's have quickly become the industry standard for communicating the environmental performance of construction products (concrete in particular). We would like to thank the Producers that participated in this initiative.

Office Update

Our office lease wasn't renewed in 2022, so we made the decision to set up home offices. We have become members of a shared
of office lease at WorkSpace, Bayers Lake. This membership allows us to host meetings and training events in equipped board
rooms, mail and courier services, event catering. We ask that you contact Pam or Taylor to make meeting arrangements. Our mail
and telephone contacts remain the same, but have been temporarily redirected.

Marketing Update

- Social Media: Throughout the pandemic networking was difficult and social media was utilized more than ever. Pam asked our
 members to connect with Concrete Atlantic on Facebook, Twitter and Linkedin. There were a series of social media campaigns
 through 2022 including; ICF, Environmental Benefits of Concrete, Concrete Testing, CDP.
- Saltwire- New Driver Campaign: Concrete Atlantic developed a short and long video promoting the opportunities for drivers in our
 industry that was featured on social media (TikTok and YouTube). Our market audience was determined to be a younger demographic looking for career opportunities. The videos direct viewers to the website www.workinconcrete.ca developed by the Association to give visitors more information on Industry roles, regional producer employers, training and CDP. The videos and statistics
 on how the 2023 campaign is going can be found on DropBox.
- Ready Mix News: Two issues of the Ready Mix News were published in 2022. The RMN gets sent out to politicians, government
 departments, education institutions, all related industry Associations affiliated with construction and design throughout Canada and

- 2022 Concrete Atlantic Scholarship: We were very pleased to continue the tradition of offering our annual scholarship to two very
 deserving individuals. The 2022 Memorial Scholarship recipients were Garson Grady and Luke Marcattili. The Board made the

Education Update

- NEW! Online Introduction to Concrete Course: There was an expressed interest for a 4-5 hour Introduction to Concrete training. This is to help all staff, contractors and students with limited knowledge of the industry to become familiar with our industry. A big Thank You to Chris Miller, Shawn Mills, and Shawn Putnam for their time and contributions in developing the program. The purpose of this course is to introduce basic concrete knowledge, customer service, overview of plant roles, and touches on safety and environmental concerns. It is our hope this will be used as an on-boarding tool for new employees. The course is available to all provincial association across the country. We are looking into expending the reach and scope of this course; looking into opportunities with truck driving schools to promote the industry throughout the Country and speaking with NSCC to incorporate the course into the Carpentry program. The Intro to Concrete promo video can be found in DropBox.
- Concrete Delivery Professional (CDP): The online program is continuing to be a huge success. Concrete Atlantic is hosting the program for the whole country and is showing signs of becoming a valued training tool.
- 2-Day Concrete Basics: Is back in 2023 and will be hosted in-person on April 17-18 at the WorkSpace office in Bayers Lake. Registration can be completed online, or by contacting the office.
- Concrete Pump Safety Certification: The 2021 Concrete Pump Safety Certification was held virtually due to Canada/US travel restrictions. For the most part, it was successful and Producers saved a significant amount of money by not having their pump operators travel to Halifax for an in-person workshop. The 2023 Pump Operator Safety Certification is scheduled for Saturday, April 22. Please contact the office ASAP if you think you want to register students. Deadline is March 31, 2023.
- Government Update
- Low Carbon Concrete: In 2021, Executive Directors on the Construction, Road Builders' and Concrete Associations in Nova Scotia were asked to have regular meetings with Deputy Ministers around low carbon and Green Procurement. The Province had enlisted Dalhousie University to investigate technologies around greener concrete. The presentation of Dalhousie's finding can be found in DropBox. Thanks to Duncan Williams, Grant Feltmate, Dalhousie University, Kent Nickerson, Bruce Casey, Kevin Nickerson, Mike Clements and Adam Auer and Ken Carrusca of the Cement Association of Canada. Colin Dickson of Dalhousie: Provincial Govt sponsor a GHG Initiative: Dalhousie untook a third party study on behalf of the Prov Govt. Reached out to Cement Industry, Concrete Producers through CANS. A report has been tabled and available for review and comment through CANS. The report is an academic deep dive and makes some significant observations and recommendations as far as the future of the Industry. There will be a follow-up presentation coming in March and is available in DropBox.
- Proposed Specifications NS Department of Public Works: Low Carbon Concrete: In 2021, Executive Directors on the Construction, Road Builders' and Concrete Associations in Nova Scotia were asked to have regular meetings with Deputy Ministers around low carbon and Green Procurement. The Province had enlisted Dalhousie University to investigate technologies around greener concrete. The presentation of Dalhousie's finding can be found in DropBox.

National Update

- SDS Sheet Update Concrete Atlantic has enlisted a company to update the Concrete Canada Safety Data Sheets on behalf of the provincial associations across Canada. Our current SDS sheets require updating. The first draft should be available next week and will be reviewed. Hopefully the final product should be complete shortly after that. Thank you to Shawn Mills for his involvement with this.
- EPD Environmental Product Declaration
- CRMCA/Concrete Canada EPD Regional Guidelines:
 - i. Conducted concrete plant surveys
 - ii. Created ACA regional technical committee
 - iii. Identified ACA regional mix design
 - iv. Created baseline EPD values using info from ACA members
 - v. Quebec and Atlantic Canada have requested the documents to be translated into French
 - vi. Move the Federal Government to utilize ACA-determined Regional EPD Bechmarks rather than creating their own requirements that the industry had no involvement with
 - vii. Created a national summary of Diesel Fuel usage at the concrete plant
 - viii. Created an industry-average EPD calculator for member use

- The Workforce Committee developed a survey for Concrete Drivers distributed through members. The purpose of this survey is to bring value to the membership by increasing awareness of the Concrete industry and by developing strategies to attract and retain new talent.
- The survey was completed by 42 completed survey, 25 drivers, 10 dispatchers and 7 pump operators.

- Worksafe NB (and PEI) has announced a premium rate reduction in 2023. NL and NS remain status quo the past few years.

NSCSA Update: Presented by Kent Nickerson

- CSNS will open a new office in Cape Breton on April 1, 2023.
- Workforce shortages continue to be a challenge which has generally had an impact on safety performance. WCB reports 2022 loss time injuries are up in Nova Scotia and overall increase of 6%. Mental Health is becoming a growing issue of concern in the Industry.
- CSNS continues to offer training online and in classroom for topics that are relevant to the Ready Mix Industry.

Cement Industry Update: Presented by Adam Auer & Steve Morrissey, Cement Association of Canada

- Cement Association of Canada is hosting Federal Lobby Days May 1-2, 2023 in Ottawa. Save the Date has been shared with ACA and
 to be shared with members. The Cement Association of Canada will try to accommodate meeting with your local MP's if you are planning
 on attending.
- Net-Zero Action Plan will be released during the 2023 Lobby Days. A draft of the Action Plan has recently been completed and in review
 with task groups/chair. Once this review is completed the Action Plan will be shared with a larger group of stakeholders.
- Net-Zero Road Map was announced in November 2022. Lobby Days will be an opportunity for the broader industry to meet and get an understanding of the Road Map.
- Codes and Standards Structure: Canadian Building and Fire Code has been dissolved and morphed into a new governance model which
 sees greater control by Government. Greater collaboration between provinces and feds. Some Industries no longer have a seat at the




